Recommended Class Placement	

Placement of students is governed by individual potential and technical proficiency, not entirely by age or amount of previous training. New students will need to call for an evaluation class before a placement can be made.

#### **SEMESTER TUITION 2017-2018**

Semester tuition is based on a nine-month calendar and divided equally between two semesters. The first semester runs from August 28 to January 13 and the second semester runs from January 16 to August 20.

Tuition is due at the beginning of each semester and must be paid in advance. No student will be allowed to take class if full or partial tuition has not been received. If you are unable to pay on time, contact Ms. Corkery for special arrangements.

Tuition must be paid in one installment or two within a semester. If you pay in two installments the second payment will be due November 1 for the first semester and March 1 for the second semester. Tuition is nonrefundable and may not be carried over as credit to any future semester.
